

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

We, J.C. Kilgore and D.H. Kilgore of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, the said J.C. Kilgore and D.H. Kilgore in and by ourselves certain note or obligation, bearing date the 12th day of January 1928

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Five Hundred and fifty (\$450.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 4th day of January A. D. 1928, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that we

the said J.C. Kilgore and D.H. Kilgore shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of February 1928, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of \$7.50

Dollars, being the regular monthly installment payable on the 4 1/2 Shares of Stock, and \$3.00

Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of \$6.90 Dollars, (\$4.50

Dollars, being the regular monthly payment of said stock and \$2.40 Dollars, being the monthly interest on balance due); for the next twenty months the sum of \$6.30 Dollars, (\$4.50

Dollars, being the regular monthly payment on said stock and \$1.80 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$5.70

Dollars, being the monthly payment on said shares of stock and \$1.20 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of \$4.50 Dollars, (\$4.50

Dollars, being the monthly payment on said shares of stock and \$1.60 Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 4 1/2 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me the said

J.C. Kilgore and D.H. Kilgore and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said J.C. Kilgore and D.H. Kilgore in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That we the said J.C. Kilgore and D.H. Kilgore in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to us

the said J.C. Kilgore and D.H. Kilgore in and well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, as that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

all that certain tract of land situated, lying and being North of the City of Greenville and Rife Mountain and described as follows: beginning at a stake on the East side of Rife Road a distance of 547.6 feet North of the Rife Mountain & Northern Railway right-of-way and running thence N. 69.5456° 515 feet to a pin; thence S. 76.5071° 485 feet to a pin on the said road; thence with the said road in a Southerly direction 100 feet to the beginning being lot number 2, as shown on a plat of Rife Mountain Park made by Brodie & Bledell on August 30, 1913 and being the same property conveyed unto us by Rosa A. Marchbanks on December 22, 1937 by deed recorded in Volume 76, at Page 276.
