TO ALL WHOM THESE PRESENTS MAY CONCERN:

of Greenville, in the County of Greenville, and the State of South Carolina, send greeting:

WHEREAS, Mrs Odella S. Freeman, the said in and by certain note or obligation, bearing date the 1st day of May 1928

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of One Thousand (\$1000.00) Dollars,

with interest thereon at the rate of eight per centum per annum, payable monthly, from the 1st day of May A. D. 1928, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said Mrs Odella S. Freeman shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns at Greenville City aforesaid, monthly, on the 20th or before the end of the month of May

1928, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Fifteen + 83/100 (\$15.83) Dollars,

being the regular monthly installment payable on the Shares of Stock, and Five + 83/100 (\$5.83) Dollars, being the monthly interest on the advance of loan until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Fourteen + 67/100 (\$14.67) Dollars,

Dollars, being the regular monthly payment on said stock and Ten + 67/100 (\$10.67) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Thirteen + 50/100 (\$13.50) Dollars,

Dollars, being the regular monthly payment on said stock and Three + 50/100 (\$3.50) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Twelve + 33/100 (\$12.33) Dollars,

Dollars, being the monthly payment on said shares of stock and Two + 33/100 (\$2.33) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eleven + 17/100 (\$11.17) Dollars,

Dollars, being the monthly payment on said shares of stock and Ten + 17/100 (\$10.17) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said ten shares of stock and the certificate thereon the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition hereunder written, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That Mrs Odella S. Freeman the said in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,

according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Mrs Odella S. Freeman

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All that certain lot of land in the City of Greenville, County and State aforesaid, having the following metes and bounds, to-wit:

Beginning at a stake on the North side of Elkins Street, 260 feet westward from the west side of Grove Street; thence along Elkins Street S. 80-08 E. 50 feet to stake; thence N. 12 1/2 E. 168 feet, 9 inches, along the line of Lot No. 7 to stake; thence N. 69 W. 57 feet 6 inches to stake; thence S. 14 W. 180 feet 3 inches to the Beginning corner, being the lot designated as Lot No. 8 of the B. E. Gier property and being the same lot conveyed to Odella S. Freeman by W. M. Foster, by deed dated May 17, 1917, recorded in the R. M. C. Office for Greenville County in Book 46, Page 378.
