or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of four Per cent
besides all costs and expenses of collection to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being
thereunto had, as will more fully appear.)

All that Piece, Parcel or lot of land in Greenville Township,

bounds, to-wit: Beginning at Berry's corner on David Street,
47 1/2 feet from the east corner of lots 72 and 73; thence
with David Street, 47 1/2 feet to corner of lot no. 7; thence S.
48-30 W. to Alley corner of lot no. 7; thence with said Alley
N. 4 1/2 E. to corner to Berry's lot; thence with Berry's line
N. 48-30 E. to the beginning corner on David Street. The Plat
above referred to has been revised so that the depth of
