at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,
bargain, sell and release unto the said *Fred S. Mayfield and his heirs and*

assigns forever, all that certain lot of land in Simpsonville S.C. Curtis Township and on Curtis Street, and having the following metes and bounds to-wit: - Beginning on Curtis Street and running with Church Street 200 feet to Old Georgia Road and thence with old Georgia Road 100 feet to corner of W. J. McKinnis estate and thence by a southerly direction 180 feet to Curtis Street; and thence with Curtis Street in a westerly direction 105 feet to the beginning corner. Also all that other tract of land in Curtis Township Greenville County and having the following metes and bounds to-wit: Beginning on Horse pen Creek near bridge and running thence N 24 - 1/2 W. 80 to Cedar and thence S. 85 - W. 124 1/2 to a stone, 4 and thence N. 69 1/2 W. 2 - 24 to stone, and thence S. 64 1/2 W. 20. 83 to a stone; thence S. 41 - E. 5 - 50 to Horse pen Creek, thence down the mean divide of Horse pen Creek to the beginning corner, and containing nine acres more or less.
