WHEREAS, I, J. D. Bridges, the said J. D. Bridges
in and by my certain Provisory note in writing, of
even date with these presents, am well and truly indebted to

G. A. Neal
in the full and just sum of Twelve hundred (\$1200.00)
Dollars, to be paid One year from date

with interest thereon, from date of said note at the rate of 8 per cent. per annum, to be
computed and paid Semi-annually

until paid in full, all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal
or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; said note further providing for an attorney's 10% of amount due
besides all costs and expenses of collection to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any
part thereof, be collected by an attorney or by legal proceedings of any kind (which is secured under this mortgage; as in and by the said note, reference being
thereunto had, as will more fully appear.)

bargain, sell and release unto the said G. A. Neal

That certain piece, parcel or tract of land
situate, lying and being in Chick Springs
Township, County and State of aforesaid, containing
2.9 acres, more or less, and described as
follows;

Beginning at pin in center of National Highway
from Greenville to Spartanburg at the intersection
of road to Figerville, said point being 4.60 chains
in northeasterly direction from center of bridge
over Enoree River; measured along center of
said National Highway; thence along west side
of Figerville Road N. 39-30 W. 6 chs. more or less
to stone; thence S. 32 E. 6.60 chs. more or less to
point in middle of Enoree River; thence, along center
of said river in an easterly direction 1.40 chs.
more or less to point in river at middle of
bridge over said river; thence along center of
National Highway N. 70-45 E. 4.60 feet to beginning
