SEND GREETING:

WHEREAS, I, *W. W. Storer*, the said *W. W. Storer*,  
in and by *my* certain *Promissory* note in writing, of  
even date with these presents, *and* well and truly indebted to  
*Maye W. Hebb*,

in the full and just sum of *Two Thousand Dollars*  
Dollars, to be paid *One year from date*

with interest thereon, from *date Oct. 1921* at the rate of *8* per cent. per annum, to be  
computed and paid *annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal  
or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who  
may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *Five per cent*

besides all costs and expenses of collection to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any  
part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage, as in and by the said note, reference being  
thereunto had, as will more fully appear.)

NOW, KNOW ALL MEN, That I, *W. W. Storer*, the said *W. W. Storer*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *Maye W. Hebb*

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to *me*, the said *W. W. Storer*

in hand well and truly paid by the said *Maye W. Hebb*.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant,  
bargain, sell and release unto the said *Maye W. Hebb*.

*All that certain piece  
parcel or lot of land in ward two of the City of Greenville  
on the east side of N. Main Street, having the  
following meter and bounds, to wit; Beginning at an  
iron pin on the east side of N. Main Street, at the  
Northwest corner of lot of W. F. Henderson being approx-  
imately 104 feet 9 inches from the Southeast corner  
of N. Main and E. Oak Streets and running thence  
with line of said W. F. Henderson S. 70-30 E. 156-  
feet 6 inches more or less, to an iron pin corner of  
lot heretofore conveyed by me to the said W. F. Hender-  
son; Thence with line of said lot N. 18-54 E. 50 feet;  
thence N. 70-27 W. 156 feet 6 inches more or less  
to an iron pin on the east side of N. Main Street;
