as "Alta Vista" and designated as Lot No. 80 on a plat of same by R.E. Dalton June 1925,  
recorded in office of R.M.C. for said County in Book F, pages 87 and 97 and described as

Beginning at corner on south side of McIver Street 59 feet from the corner of McIver Street and  
Afton Avenue, and running thence in a straight line along line of lot No. 79, 178.7 feet to
