Thorton*, her heirs and assigns:

All that certain piece or parcel or lot of land, situate, lying and being in Greenville Township, County and State aforesaid, on the north side of Augusta Road, being known and designated as lot No. 94 of a Sub-division known as *Country Club Estates*, according to plat made by *Dalton and Nevers*, Oct. 1926, recorded in the R.M.C. Office for Greenville County in Plat Book *Page* reference being craved to said plat for a more complete description. This mortgage is junior to mortgage indebtedness of \$250.00.

For value received, I hereby assign, transfer and set over the within mortgage and note which it secures, to *Strofford College*, without recourse, This the 11th day of Oct. 1927.
