That we, *Burke C Jones and Lida H. Jones*

SEND GREETING:

WHEREAS, *we*, the said *Burke C Jones and Lida H. Jones*
in and by *our* certain *promissory* note in writing, of
even date with these presents, *are* well and truly indebted to

Wm Schuweis

in the full and just sum of *Fifteen hundred Dollars*
Dollars, to be paid *two years from date*

with interest thereon, from *June 1st 1927 until paid* at the rate of *6* per cent. per annum, to be
computed and paid *annually*

until paid in full, interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of *ten percent of*

added to the amount due on said note, to be collected as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto, shall as will more fully appear.)

NOW, KNOW YE, that the said *Burke C Jones and Lida H. Jones*
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *Wm Schuweis*

according to the terms of said note, and also in consideration of the further sum of Three Dollars, to *us*, the said

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *Wm Schuweis, his heirs and*

assigns; All that tract or parcel of land, situated in the County of Greenville, State of South Carolina and described as follows: About two and one half (2 1/2) miles from the City of Greenville, known as Mountain View, and being designated as lot No. 67 of Block B, as shown on a plat of the said Mountain View of record in the R.M.C. Office for Greenville County in Plat Book "A" at pages 396 and 397, said lot herein conveyed being approximately Fifty (50) feet in width and One Hundred Forty five (145) feet in depth and having such metes and bounds as are shown on the plat above mentioned, reference to which is hereby made, and being the same lot conveyed to G. T. and Lida H. Mc Kinney by deed dated February 1st 1924, Book 76- Page 284. Also deed dated July 8th 1927 in which G. T. Mc Kinney deeded all his one half interest to L. J. Mc Kinney recorded in R.M.C. Office for Greenville County in Book 82, page 542, This being lot conveyed to us by deed dated October 1st 1924, by L. J. Mc Kinney and recorded in Book #2 - page 246 of Deeds and Book 97, Page 58 in the R.M.C. Office for Greenville County.
