at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *Norwood National Bank of Greenville,*

*South Carolina. All those three lots and State aforesaid, and in Greenville Township, near the City of Greenville, designated as Lots 59, 60 and 61 on a plat of G. R. Stargel's property made by deed June 12, 1924, said plat recorded in the office of R.M.C. for said County in Plat Book C, page 190, and being therein described as follows:*

*Lot No. 59: - Beginning at joint corner of lots 58 and 59 and running thence along an unnamed street N. 14.062. 63.7 feet to corner of lot No. 60; thence along line of Lot No. 60, 245 ft; thence S. 2.086. 63.7 ft. to corner of Lot No. 58; thence along line of lot No. 58, 261 feet to the beginning corner*

*Lot No. 60: - Beginning at joint corner of lots 59 and 60 and running thence along an unnamed street N. 14.062. 63.7 feet to corner of lot 61; thence along line of lot No. 61, 225 ft; thence S. 2.086. 63.7 ft. to corner of Lot 59; thence along line of Lot No. 59 245 ft. to the beginning*

*Lot No. 61: - Beginning at joint corner of lots 60 and 61 and running thence along an unnamed street N. 14.062. 63.7 feet to iron pin; thence N. 81. 462. 200 ft. to iron pin; thence S. 2.086. 124.8 ft. to corner of Lot 60; thence along line of Lot No. 60, S. 79. 336. 225 ft. to the beginning corner, being the same lots of land conveyed to me by G. R. Stargel by deed dated Dec. 9, 1925, recorded in office of R.M.C. for said County in Book 105, at page 525.*

*Less, however a parcel of Lot No. 59 fronting 30 ft. on the street herein referred to and running back in parallel lines the depth of lot No. 59, having a frontage on the rear of 30 feet, - this 30 ft. rectangle having been deeded by me to G. S. Stargel.*
