

AGREEMENT FOR EXTENSION OF LOAN NO. 85-6-86-

WHEREAS, there remains unpaid on a certain note executed and delivered by *H. N. Watson*

to

The Prudential Insurance Company of America, secured by a *mortgage* upon real estate in

Greenville County, *South Carolina*, dated *April 26th*, 19*27*, and recorded in said

County on *May 2nd*, 19*27*, in Volume *123* of *mortgages* on Page *214*, in the sum of

Eleven thousand eight hundred fifty (\$11,850.00) Dollars,

with interest from *April 26th*, 19*27*, and,

WHEREAS, title to the mortgaged premises is now vested in *H. N. Watson*

subject to said *mortgage*

and, WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said *H. N. Watson* hereby agree *to* to pay the principal sum remaining due as aforesaid as follows:

Eleven thousand eight hundred fifty (\$11,850.00) dollars on April 26th, 1927

with interest thereon from *April 26th*, 19*27*, to *April 26th*, 19*32*, at the rate of *five and one-half* per cent. per annum, payable *Semi* annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make payments of one hundred (\$100.00) dollars or any multiple thereof on account of said principal sum on any interest payment date.

And the parties to this agreement hereby consent to said extension and agree that said *mortgage* shall continue a first lien upon said premises, and that said note and *mortgage* and all their covenants and conditions shall remain in force except as herein modified.
