

AGREEMENT FOR EXTENSION OF LOAN NO. 85584

WHEREAS, there remains unpaid on a certain note executed and delivered by Jeff D Gilbreath

The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated April 26, 1922, and recorded in said County on April 29, 1922, in Volume 123 of mortgages on Page 212, in the sum of Seven Thousand (\$7,000.00) Dollars,

with interest from April 26, 1927, and, WHEREAS, title to the mortgaged premises is now vested in Jeff D Gilbreath

subject to said mortgage and,

WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said Jeff D Gilbreath hereby agree to pay the principal sum remaining due as aforesaid as follows:

Three Hundred Fifty (\$350.00) Dollars on April 26, 1928; Three Hundred Fifty (\$350.00) Dollars on April 26, 1929; Three Hundred Fifty (\$350.00) on April 26, 1930; Three Hundred Fifty (\$350.00) Dollars on April 26, 1931, and Fifty Six Hundred (\$5600.00) on April 26, 1932,

with interest thereon from April 26, 1927, to April 26, 1932, at the rate of six per cent. per annum, payable semi-annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments of \$100.00 or any multiple thereof on the principal sum of said note at any interest payment date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
