

AGREEMENT FOR EXTENSION OF LOAN NO. 88875

WHEREAS, there remains unpaid on a certain note executed and delivered by Julia C. Robertson to The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated July 10, 1922 and recorded in said County on July 17, 1922, in Volume 123 of mortgages on Page 12, in the sum of Twenty nine hundred sixty one Dollars, with interest from July 10, 1927 and

WHEREAS, title to the mortgaged premises is now vested in Julia C. Robertson subject to said mortgage and,

WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said Julia C. Robertson hereby agree to pay the principal sum remaining due as aforesaid as follows:

on the first day of each month beginning on the first day of August 1927 the sum of Twenty one \$21.00 Dollars to be applied on the principal of said amount due on said note and also, at the same times, interest at the with interest thereon from 19 to 19 at the rate of six (6%) per cent. per annum, payable first day of each month on the 1st day of July 1932

PREPAYMENT PRIVILEGE:

Additional payments of not less than one hundred Dollars (\$100), at any one payment, in multiples of the monthly installment of principal, may be made on the principal at any interest payment date, and the amount so paid shall be credited on said mortgage. And the parties to this agreement hereby consent to said extension and agree that said mortgage

shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.

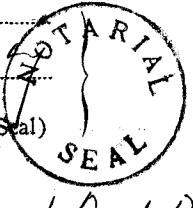
