

AGREEMENT FOR EXTENSION OF LOAN NO. 92991

WHEREAS, there remains unpaid on a certain note executed and delivered by N. N. Halcombe to The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County, South Carolina, dated October 30th, 1922, and recorded in said County on November 14, 1922, in Volume 123 of Mortgages on Page 222, in the sum of Twenty six hundred (\$2,600.00) Dollars, with interest from October 30th, 1927,

WHEREAS, title to the mortgaged premises is now vested in N. N. Halcombe subject to said mortgage and,

WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said N. N. Halcombe hereby agree S. to pay the principal sum remaining due as aforesaid as follows:

one hundred (\$100.00) Dollars on October 30, 1928; one hundred (\$100.00) Dollars on October 30, 1929; one hundred (\$100.00) Dollars on October 30, 1930; one hundred (\$100.00) Dollars on October 30, 1931, and Twenty two (\$2200.00) Dollars on October 30, 1932.

with interest thereon from October 30th, 1927, to October 30th, 1932, at the rate of Six (6%) per cent. per annum, payable Semi annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE: Privilege is given to make additional Payments of \$100.00 or any multiples thereof on the Principal at any interest Payment date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
