

AGREEMENT FOR EXTENSION OF LOAN NO. 131849

WHEREAS, there remains unpaid on a certain note executed and delivered by R. L. Owen

to ✓
The Prudential Insurance Company of America, secured by a first mortgage upon real estate in Greenville County, South Carolina dated August 25th, 1927, and recorded in said County on August 25th, 1927, in Volume 123 of Mortgages on Page 239, in the sum of Twenty Four Hundred (\$2,400.00) Dollars, with interest from August 25th, 1927, and,

WHEREAS, title to the mortgaged premises is now vested in R. L. Owen

subject to said mortgage and,

WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said R. L. Owen

hereby agree to pay the principal sum remaining due as aforesaid as follows: One Hundred Fifty (\$150.00) Dollars on September 19th, 1930; One Hundred Fifty (\$150.00) Dollars on September 19th, 1931; One Hundred Fifty (\$150.00) Dollars on September 19th, 1932; One Hundred Fifty (\$150.00) Dollars on September 19th, 1933 and Eighteen Hundred (\$1,800.00) Dollars on September 19th, 1934; with interest thereon from August 25th, 1927, to September 19th, 1934, at the rate of six (6%) per cent. per annum, payable Resid - annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

Privilege is given to make additional payments of One Hundred (\$100.00) Dollars, or any multiple thereof on said note at any interest payment date.

And the parties to this agreement hereby consent to said extension and agree that said mortgage

shall continue a first lien upon said premises, and that said note and mortgage and all their covenants and conditions shall remain in force except as herein modified.
