

AGREEMENT FOR EXTENSION OF LOAN NO. 65-904

WHEREAS, there remains unpaid on a certain note executed and delivered by S. C. Harrison to The Prudential Insurance Company of America, secured by a Mortgage upon real estate in Greenville County, South Carolina, dated December 22, 1925, and recorded in said County on December 31, 1925, in Volume 171 of 1 on Page 14, in the sum of Thirty Five Hundred and no/100 (\$3500.00) Dollars, with interest from November 1st, 1930, and,

WHEREAS, title to the mortgaged premises is now vested in Maria Harrison subject to said Mortgage and,

WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said Maria Harrison hereby agrees to pay the principal sum remaining due as aforesaid as follows:

The principal sum of Thirty Five Hundred dollars (\$3500.00) being payable in annual installments as follows, viz; Beginning November 1st 1931 and on the same day in each succeeding year thereafter the sum of \$400.00 and the balance of said principal sum being payable on the 1st day of November 1935-1st with interest thereon from November 1st 1930 to November 1st 1935, at the rate of Seven (7%) per cent. per annum, payable annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

(Privilege is given to make additional payments of \$100.00 or any multiple thereof of the principal sum of said note on any interest maturity date, and the amount so paid shall be credited).

And the parties to this agreement hereby consent to said extension and agree that said Mortgage shall continue a first lien upon said premises, and that said note and Mortgage and all their covenants and conditions shall remain in force except as herein modified.
