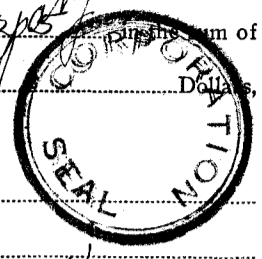


AGREEMENT FOR EXTENSION OF LOAN NO. 282

WHEREAS, there remains unpaid on a certain note executed and delivered by A. G. Huff to The Prudential Insurance Company of America, secured by a mortgage upon real estate in Greenville County South Carolina, dated January 12th, 1926, and recorded in said County on February 22nd, 1926, in Mortgage Book 174, on Page 385, of Two Thousand Dollars (\$2,000.00) with interest from January 1st, 1926, and



WHEREAS, title to the mortgaged premises is now vested in Edna Tollison subject to said mortgage in full & good and, and WHEREAS, the said Insurance Company has been requested to make said note payable as hereinafter agreed, which it has consented to do in consideration of the payments to be made as herein provided.

NOW, THEREFORE, the said A. G. Huff hereby agree to pay the principal sum remaining due as aforesaid as follows:

The principal sum of \$2,000.00 is payable in annual installments as follows: Beginning on the 1st day of January, 1932, and on the same day in each succeeding year thereafter the sum of \$500.00 and the balance of said principal sum being payable on the 1st day of January, 1936, with interest thereon from January 1st, 1931, to January 1st, 1936, at the rate of six (6%) per cent. per annum, payable annually; and with interest after maturity as set forth in said note.

PREPAYMENT PRIVILEGE:

(Privilege is given to make partial payment of \$400.00 or any multiple thereof of the principal sum of said note on any interest maturity date, and the amount so paid shall be credited)

And the parties to this agreement hereby consent to said extension and agree that said mortgage shall continue a first lien upon said premises, and that said note and mortgage #3784 March 15th 1935 at Greenville S.C. at the office of Walker Evans & Cogswell Co. Charleston S.C. and copies shall remain in force except as herein modified.
