WHEREAS, *Lakeside Realty Corporation*, the said *Lakeside Realty Corporation* a corporation chartered under the laws of the State of South Carolina, in and by *its* certain *promissory* note in writing, of even date with these presents, *is* well and truly indebted to *C. S. James* in the full and just sum of *Thirty-five Hundred (3500.00)* Dollars, to be paid *one year after date*

with interest thereon from *date* at the rate of *7* per centum to be computed and paid *semi annually* until paid in full; all interest not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interest to be placed, and the holder should place, the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses, including 10 per cent. of the indebtedness, as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW, KNOW ALL MEN, That, *Lakeside Realty Corporation*, the said *Lakeside Realty Corporation*, in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *C. James* according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *it*, the said *Lakeside Realty Corporation* in hand well and truly paid by said *C. S. James* at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said *C. S. James, his heirs and assigns:*

*All that certain piece, parcel or lot of land situate, lying and being in the City of Greenville, in the County and State aforesaid: Beginning at an iron pin on Richardson Street, corner of lot of James McPherson, and running thence with said Richardson Street S. 19 1/2 ft., fifty (50) feet to an iron pin; thence N. 70 1/2 ft. to be hundred and fifty-two (152) feet to a stake; thence N. 19 1/2 ft. fifty (50) feet to a stake; thence S. 70 1/2 ft. one hundred and fifty-two (152) feet to the beginning corner.*
