until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid; then the whole amount evidenced by said note to become immediately due at the option of the holder hereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent

besides all costs and expenses of collection to be added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage; as in and by the said note, reference being thereunto had, as will more fully appear.)

C. at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Great American Life Insurance Company, of Greenville, S. C.

All those two certain pieces of land or lots of land in the County and State aforesaid, near the City of Greenville, in the subdivision known as "Hambatanah", and situated on the north side of Curton Street, and known as lots nos. 2 and 3 of Block "F" on revised plat of the said property to be recorded in A.M.C. office for said County.

The said lots have the following meters and bounds: Beginning at a stake on the north side of said Street, at corner of lot #1, and running thence along said Street N. 55-56 E. 121 feet to stake at corner of lot #4; thence along said lot 184 feet to stake at corner of lot #17; thence along said lot, and lot #16, 120 feet to a stake at corner of lot #1; thence along said lot 200 feet to the beginning point on said Curton Street.
