Allie B. Gillespie, in the full and just sum of one thousand (\$1,000.00) Dollars, to be paid one year from date

with interest thereon, from date of recording until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, Mamie Lee Turney, the said Mamie Lee Turney in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Allie B. Gillespie

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me, the said Mamie Lee Turney

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Allie B. Gillespie

all that piece, parcel or tract of land situate, in the County aforesaid, containing one hundred thirty six and three fourths (136 3/4) acres, more or less, and having the metes and bounds more fully described in a deed from E. Inman, Master, to Allie B. Gillespie, said deed having been executed as the result of a sale in the case of E. W. Barton vs E. L. Barton, et al reference being hereby made to said deed for a more complete description, said deed being dated April 7, 1926, and recorded in Vol 110, page 294. This being a purchase money mortgage given by me to secure the said Allie B. Gillespie for the balance of the purchase money due by me upon the sale of the said property to me.
