*The South Carolina National Bank*  
in the full and just sum of *Thirty five Hundred (\$3500.00)*  
Dollars, to be paid *sixty days from date*

with interest thereon, from *date hereof* at the rate of *8* per cent, per annum to be  
computed and paid *semi-annually*  
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note *to become immediately due, at the option of the holder hereof, who may*  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per centum*  
besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this moragage); as in and by the said note, reference being

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-  
gain, sell and release unto the said *The South Carolina National Bank,*  
*their heirs and assigns:*

State and County aforesaid, and being desig-  
nated as Lot No. 24 of North Hills and having  
the following metes and bounds, to-wit:  
Beginning at a point on the East side of  
Mc Donald Street, fifty four and nine tenths

fifty (50) feet, thence S. 70-30 E. one hundred sixty
