SEND GREETING:

WHEREAS, I, the said Irene Smith Bryant
in and by my certain promissory note in writing, of
even date with these presents, am well and truly indebted to

Mamie H. Fulmer & Ruth Cox Curry
in the full and just sum of Four hundred
Dollars, to be paid as follows: \$25.00 on the first day of February 1928,
and \$25.00 on the first day of each month thereafter
until paid in full

with interest thereon, from date at the rate of 8 per cent. per annum to be
computed and paid annually

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten percent

besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said Irene Smith Bryant
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mamie H. Fulmer
and Ruth Cox Curry

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me the said
Irene Smith Bryant
in hand well and truly paid by the said Mamie H. Fulmer & Ruth
Cox Curry

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-
gain, sell and release unto the said Mamie H. Fulmer & Ruth Cox Curry their heirs
and assigns:

All that certain piece, parcel or lot of land, siting being
and situate in the County of Greenville, State of South
Carolina and in the town of Fountain Inn, South, the
following notes and bounds, to wit: Beginning at an
iron pin, intersection of Jones Mill Road Street & Weston
Street, running thence N. 36.25 W. 250 feet to an iron pin
on the East side of Extension of Weston Street; thence N. 31 E
77.50 feet to an iron pin; thence S. 40.50 E. 250 feet to an iron
pin in the centre of Jones Mill Road Street; thence S. 32
W. 82.50 feet along centre of Jones Mill Road Street to the
beginning corner in centre of said Road. Bounded on
the North by lands of the said Mamie H. Fulmer and
Ruth Cox Curry, on the East by lands of the said Mamie
H. Fulmer & Ruth Cox Curry, on the South by Jones Mill
Road and on the West by extension of Weston Street.
