And the said Mortgagor agree to insure the house and buildings on said lot in a sum not less than Seven Thousand

(7000.00) Dollars (in a company or companies satisfactory to the mortgagee) and keep the same insured from loss or damage

by fire, and assign the policy of insurance to the said mortgagee, and that in the event that the mortgagor shall at any time fail to do so, then the said mortga-

gee may cause the same to be insured in his name, and reimburse himself

for the premium and expenses of such insurance under this mortgage, with interest.

And if at any time any part of said debt, or interest thereon be past due and unpaid, I hereby assign the rents and profits of

PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to this instrument that if the said mortgagor, do and shall well and truly pay or cause to be paid onto the said mortgagee, the said sum of money aforesaid, with interest thereon, if any be due, according to the true intent and meaning of the said note, then this debt of bargain and sale shall cease, determine, and be utterly null and void; otherwise to remain in full force and virtue.
