WHEREAS, *J. B. League*, the said *J. B. League*
in and by *my* certain *promissory* note in writing, of
even date with these presents, *am* well and truly indebted to

Sue H. Earle
in the full and just sum of *nineteen hundred and thirty five*
Dollars, to be paid *one year after date*

with interest thereon, from *date of full* at the rate of *eight* per cent. per annum to be
computed and paid *semi-annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per cent*

of amount besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-
gain, sell and release unto the said *Sue H. Earle, her assigns and heirs*
forever

Township, Greenville County, South Carolina
about two and one half miles southeast of
Greenville Court House.*

*Beginning on west side of Jarvis Road on a
culvert corner of land of Lewis and running
thence N. 70-34 W. 629.6 feet to a corner on
Lewis land; thence with Lewis land S. 78-51 W.
166.1 feet to Lewis land; thence S. 21-13 E. 431.3
feet to Jarvis Road; thence with Jarvis Road
N. 69-40 E. 640.4 feet to the beginning corner,
being the lots known and designated as
Lots 9-10-11-12-13-14-15 and 16 of L. W. Jarvis
land according to a plat made by R. E. Dalton
June, 1921, except, however, a lot conveyed
