in the full and just sum of *Sixteen Hundred Fifty (\$650.00)*
Dollars, to be paid *November 30, 1928*

with interest thereon, from *date* at the rate of *8* per cent. per annum to be
computed and paid *annually*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *ten per cent of*
amount due besides all costs and expenses of collection, to be
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being

gain, sell and release unto the said *Mrs. R. H. Plant and W. C. Rusk*

All that certain piece, parcel or lot of land
in Chick Springs Township, near the Town of
Greer, said County and State, beginning at an
iron pin on Piedmont Avenue and running
northwestwardly 156 feet to an iron pin; thence
northwesterly 55 feet to a point; thence southeast-
erly 156 feet to a point on Piedmont Avenue;
thence along the westerly edge of said Piedmont
Avenue for a distance of 55 feet to the begin-
ning of a street and thence along the westerly
edge of said street for the entire
depth of said street and thence for the entire
width of said street and Lot No. 5, and adjoining
