until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of Fifty (\$50.00) besides all costs and expenses of collection, to be

all those certain lots of land in Greenville Township, Greenville  
County, South Carolina, about 1/2 mile North of Greenville  
Court House, S.C., being lots 107 and 108 according to plat  
made for Greenville Trust Company, recorded in Plat Book A,  
Page 177, R.M.C. Office for said Greenville County. Each lot has  
a frontage of fifty (50) feet on Biggs Avenue and a depth  
of One Hundred Fifty (150) feet.
