

TOGETHER with, all and singular, the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said Premises unto the said The Woodside National Bank,

do hereby bind ourselves, our Heirs, Executors and Administrators,

to warrant and forever defend, all and singular the said premises unto the said The Woodside National Bank,

And the said Mortgagor agree to insure the house and buildings on said lot in a sum not less than fifteen hundred  
or 1500 Dollars (in a company or companies satisfactory to the mortgagee), and keep the same insured from loss or damage  
by fire, and assign the policy of insurance to the said mortgagee, and that in the event that the mortgagor shall at any time fail to do so, then the said mortga-  
gee may cause the same to be insured in its name, and reimburse itself

And if at any time any part of said debt, or interest thereon be past due and unpaid we hereby assign the rents and profits of

Circuit Court of said State may, at chambers or otherwise, appoint a receiver with authority to take possession of said premises and collect said rents and profits applying  
the net proceeds thereof (after paying costs of collection) upon the said debt, interest, costs or expenses; without liability to account for anything more than the rents  
and prongs actually collected.

PROVIDED ALWAYS, NEVERTHELESS, and it is the true intent and meaning of the parties to these Presents, that if we  
the said mortgagor S., do and shall well and truly pay or cause to be paid, unto the said mortgagee, the said debt, or sum of money aforesaid, with interest thereon,  
if any be due, according to the true intent and meaning of the said note, then this deed of bargain and sale shall cease, determine, and be utterly null and void; other-  
wise to remain in full force and virtue.
