TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, Sally D. Sheek, the said Sally D. Sheek  
in and by my certain Promissory note in writing, of  
even date with these presents, am well and truly indebted to  
Nellie J. Cole  
in the full and just sum of Six hundred (\$600.00)  
Dollars, to be paid one year from date

with interest thereon, from date at the rate of eight per cent. per annum to be  
computed and paid semi-annually  
until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or  
interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may  
sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of ten per cent of  
amount - besides all costs and expenses of collection, to be  
added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part  
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being  
thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said Sally D. Sheek  
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Nellie J. Cole  
according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me  
Sally D. Sheek  
in hand well and truly paid by the said Nellie J. Cole

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-  
gain, sell and release unto the said Nellie J. Cole her heirs and assigns  
forever.

All that certain lot of land, situate about  
two and one-half (2 1/2) miles southeast of the city  
of Greenville, in the county and State aforesaid,  
on the west side of Faris Road, and having the  
following metes and bounds, to-wit:  
Beginning at the joint-corner of Lots  
nos. 7 and 9, according to revision of a plat  
of a part of the S. W. Faris property made by R. E.  
Dalton June 1921, and thence runs N. 68-47 E. 75-  
feet to an iron pin; thence N. 21-13 W. 200 feet  
to an iron pin; thence S. 68-47 W. 75 feet to an  
iron pin joint corner of lots 7, 8 and 10; thence  
S. 21-13 E. 200 feet to the point of beginning,  
and being the same lot conveyed to Sally D. Sheek  
by W. B. Caution by deed dated May 25, 1928  
to be recorded, and being the same land conveyed  
to W. B. Caution by J. B. League.
