SEND GREETING:

WHEREAS, *I*, the said *Aimee M. Richey*  
in and by *my* certain *promissory* note in writing, of  
even date with these presents, *and* well and truly indebted to  
in the full and just sum of *Five Dollars*  
Dollars, to be paid *one year*

with interest thereon from *the day of the date of the mortgage executed*  
computed and paid *on the 1st day of January 1922*  
interest be at any time due and unpaid, then the whole amount evidenced by said note  
sue thereon and foreclose this mortgage and note further providing for an attorney's fee *of 10%*  
added to the principal on said note to be collectible as part thereof, and if any portion of principal or  
thereof, be collected by an attorney or by legal proceedings of any kind, all of which shall be secured under this mortgage; as in and by the said note, reference being  
thereunto had, as will more fully appear.

NOW, KNOWINGLY and lawfully appearing before me, the undersigned Notary Public for the County of Greenville, South Carolina, the said *Aimee M. Richey*  
in consideration of the said debt and sum of money, and for the better securing the payment thereof to the said *Carroll H. & Andrea J. Anderson*  
according to the terms of the said note, and also in consideration of the further sum of *Three Dollars*, to the said *Aimee M. Richey*  
of *Greenville, South Carolina*, in hand well and truly paid by the said *Carroll H. & Andrea J. Anderson*  
at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-  
gain, sell and release unto the said *Carroll H. & Andrea J. Anderson*:

All that piece, parcel or lot of land in  
Greenville County, South Carolina, on the West  
side of Lavinia Avenue in the city of Greenville,  
and being a portion of the Rawley place and  
having the following metes and bounds,  
to-wit: Beginning at a stake on Lavinia  
Avenue, joint corner of Lots Nos. 16 and 17,  
and running N. 21.45 W. sixty (60) feet to a stake,  
joint corner of Lots Nos. 17 and 18; thence  
with said joint line N. 76-30 W. one hundred  
and eighty feet to a point on Glover Street;  
thence with said Glover Street S. 21.45 E. sixty  
(60) feet to a point, joint corner of Lots Nos. 16  
and 17; thence with said joint line N. 76-30 W.  
one hundred and eighty feet (180) to the begin-  
ning corner; this being Lot No. 17 according to  
plat made by W.A. Adams, in January, 1914, and  
being the same lot of land conveyed to me  
by J. W. Gantt by his deed dated April 22, 1921,  
and recorded in the R.M.C. office for Greenville
