SEND GREETING:

WHEREAS, I, the said *Sallie B. Vaughn*
in and by *my* certain *promissory* note in writing, of
even date with these presents, *am* well and truly indebted to

C. C. McManaway
in the full and just sum of *one hundred fifty and no/100*
Dollars, to be paid *thirty days after date*

with interest thereon, from *date of full pay. 26th* at the rate of *8* per cent. per annum to be
computed and paid *monthly*

until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or
interest be at any time past due and unpaid, then the whole amount evidenced by said note to be some immediately due, at the option of the holder hereof, who may
sue thereon and foreclose this mortgage and note further providing for an attorney's fee of *ten per centum*
besides all costs and expenses of collection, to be
added to the amount due on said note to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part
thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being
thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That I, the said *Sallie B. Vaughn*
in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *C. C. McManaway*

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *me*, the said

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bar-
gain, sell and release unto the said *C. C. McManaway*,

all that certain piece, parcel or lot of land
in the City and Township of Greenville, State
of South Carolina,

beginning at a stake at the corner of
the intersection of East Stone Avenue and
a sixty foot unnamed street and running
thence with Stone Avenue S. 71-506. Sixty-Six (66)
feet to corner of lot number 63; thence
with line of lot number 63, S. 20-19th. one hun-
dred twenty-five (25) feet to the corner of lot
of C. C. Campbell; thence N. 71-50th. sixty-six (66) feet
along the line of lot of Campbell to a point
on the aforesaid unnamed street, which
point is 125 feet from the Southern side
of Stone Avenue; thence N. 19-20 C. one hundred
twenty-five (25) feet along the line of said
unnamed street to beginning.
