WHEREAS, we, *Lizzie Williams and Janie Williams* in and by *our* certain *promissory* note in writing, of even date with these presents, *am* well and truly indebted to

Mrs. Lillie A. Nash in the full and just sum of *Three hundred Seventeen and 25/100* Dollars, to be paid *on the first day of September A. D. 1928.*

with interest thereon, from *date* computed and paid *quarterly* ²⁹ *29* until paid in full. all interest not paid when due to bear interest at *6* per cent. per annum to be

interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage, said note further providing for an attorney's fee of *\$75.00*

besides all costs and expenses of collection, to be added to the amount due on said note, to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt or any part thereof, be collected by an attorney or by legal proceedings of any kind (all of which is secured under this mortgage), as in and by the said note reference being thereunto had, as will more fully appear.

NOW, KNOW ALL MEN, That, we, *Lizzie Williams and Janie Williams* in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said *Mrs. Lillie A. Nash*

according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *us* the said *Lizzie Williams and Janie Williams* in hand well and truly paid by the said *Mrs. Lillie A. Nash*

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said *Mrs. Lizzie A. Nash, her heirs*

and assigns forever; all that certain piece, parcel or lot of land situated lying and being City and County of Greenville, State of South Carolina, on north Calhoun Street, and having the following meters and bounds, to wit: Beginning at a stake on Calhoun Street 95 feet from the northeast corner of Calhoun and McCall Street and running thence with Calhoun Street n. 69 3/4 E. 45 feet; thence n. 20 1/2 w. 70 1/2 feet; thence S. 69 3/4 w. 49 feet; thence S. 20 1/2 E. 70 1/2 feet to the beginning corner, and being the same lot of land conveyed to Phillip Williams and Elizabeth Williams by Mrs. Mattie A. McCall by deed dated Sept 8th, 1911, and recorded in the R. M. C. office for Greenville County in Book Vol 13 at page 422.
