WHEREAS, *I*, W. J. Patrick, the said W. J. Patrick SEND GREETING:

in and by my certain promissory note in writing, of even date with these presents am well and truly indebted to THE PEOPLES BUILDING AND LOAN ASSOCIATION, a corporation incorporated under the laws of the State of South Carolina, in the full and just sum of

Two Thousand Five Hundred (2500.00)

DOLLARS,

to be paid on or before the date when the 18 A. Lien Released by 10 day of June Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent, per annum, payable

weekly on or before Saturday night of each and every week until paid in full and if I fail to pay said interest or to comply in all respects with the Constitution and By-Laws of said Association, for the space of thirty days after said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the land described property, by way of taxes or insurance, the same to be added to the amount due on said note and to be collectible as part thereof together with a reasonable attorney's fee, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I the said mortgagor in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE PEOPLES BUILDING AND LOAN ASSOCIATION (according to the terms of the said note,

and also in consideration of the further sum of Three Dollars, to me the said mortgagor in hand well and truly paid by the said THE PEOPLES BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said THE PEOPLES BUILDING AND LOAN ASSOCIATION, its successors and assigns, all that certain piece, parcel and lot of land lying, being and situate in Greenville County, in the State of South Carolina, as follows, to-wit:

*being known and designated as part of lot No. 116, of East "A" plat of said property recorded in the office of the C.P.P.C. for Greenville County in plat book "A" at page 383, more fully described as follows: Beginning at a stake on the northeast side of Ebaugh Avenue, 35 feet from the right of way of C. & W. C. Ry. Co., running thence with line of lot No. 115, as shown on said plat, N. 35.00 E. 140 feet to a stake in line of lot No. 115, thence N. 59.45 W. 50 feet to a point in line of lot No. 117, which point is 140 feet from Ebaugh Avenue, thence with line of lot No. 117, S. 35.00 W. 140 feet to Ebaugh Avenue, thence with Ebaugh Avenue, S. 55.00 E. 50 feet to the point of beginning.*
