WHEREAS, we, the said Mary Jane Harris and Nellie Fisher

Eight Hundred (\$800.00) DOLLARS,

to be paid on or before the date when the Series of the Instalment Stock of the said THE PEOPLES BUILDING AND LOAN ASSOCIATION

NOW, KNOW ALL MEN, That the said mortgagor in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said THE PEOPLES BUILDING AND LOAN ASSOCIATION (according to the terms of the said note,

and also in consideration of the further sum of Three Dollars, to us, the said mortgagor in hand well and truly paid by the said THE PEOPLES BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said THE PEOPLES BUILDING AND LOAN ASSOCIATION, its successors and assigns, all that certain piece, parcel and lot of land lying, being and situate in Greenville County, in the State of South Carolina, as follows, to-wit:

On Parker Street near Buncombe Street in the City of Greenville described as follows: Beginning at a point on Parker Street, corner of a twenty foot alley, running thence with said 20 foot alley, S. W. 116 feet to Lfidie Williams line, thence with her line S. W. 46 feet and 2 inches; thence N. W. parallel with the first line mentioned above, 116 feet to Parker Street, thence with Parker Street, N. E. 46 feet and 2 inches to the beginning corner. This lot contains 5355 square feet more or less.
