an attorney, which, in addition to the said debt, is hereby secured and made a lien on the premises as in and by the said Bond and Condition thereof, reference being had thereunto, will more fully appear.

NOW, KNOW ALL MEN, That

L. R. Mason the saidin consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION, of Greer, Greenville County, South Carolina, according to the condition of said Bond; and, also, in consideration of the further sum of THREE DOLLARS, to *me* the said*L. R. Mason*, in hand, well and truly paid by the said Citizens Building and Loan Association of Greer, Greenville County, South Carolina, at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged,the said *L. R. Mason* have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said Citizens Building and Loan Association, of Greer, Greenville County, South Carolina, all that lot of land, in said State and County, near the City of Greer, on the

side of National Highway Street -
 having the following metes and bounds, to wit:-
 Beginning at iron pin on New County Highway and runs thence with said Highway 103 feet to an iron pin, thence along an alley-way 96 feet to an iron pin, thence 41 feet to the left corner containing 2478 sq. ft. more or less, back being known as Lot #2 on a plat of land belonging to *Spoad & Brackman*.

Also, all that other parcel of land situated as above and being a strip of land 5 ft. wide along the 96 ft. line of the above described lot formerly one-half of a 10 ft. alley-way the above being the same land conveyed to me by *W. T. Brackman* and *J. T. Spoad* by deed recorded in R.M.C. Office for Greenville County in Vol 50, page 132.

Also, all that other tract of land situated lying and being in the State and County of South Carolina in *Chick Springs Township*, near the Town of Greer, having the following metes and bounds to wit:- Being lots nos. 3, 4, and 5 as shown by plat known as *Flemingham Heights* with a frontage of 150 feet on National Highway and having a depth of 204.6 feet on East side and 197.4 feet on the West side, back line same width as front.
