WITNESSETH, Whereas, the said party of the first part is indebted to said MECHANICS BUILDING AND LOAN ASSOCIATION in the sum of  
One Hundred, Fifty and no/100 (\$150.00)  
Dollars, money loaned this day, with interest thereon from this date at the rate of eight  
per cent. per annum, payable weekly,

the payment whereof the said party of the first part is anxious to secure:

Now, therefore, in consideration of the premises, and in further consideration of one dollar to him in hand paid, the receipt whereof is hereby acknowledged, the said party of the first part has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the said party of the second part all that certain piece, parcel and lot of land lying in Greenville County, in the State aforesaid, as follows, to-wit:

All that certain piece, parcel or lot of land, situate, lying and being in Greenville County, State of South Carolina, about two miles northwest of the Greenville County Courthouse, on the Franklin Road, and having the following metes and bounds, to-wit: Beginning at a point on the East side of said Franklin Road at corner of lot now or (formerly) belonging to Louise Noble (see her deed recorded in Vol. 79 at page 191) said point being 244 feet from the corner of Buncombe Road and Franklin Roads, and running thence with the Franklin Road N. 32-35 E. 63 feet to stake on side of said Road; thence parallel with Buncombe Road S. 57-25 E. 200 feet to stake in line of lot No. 7; thence along the line of lot No. 7, parallel with Franklin Road S. 32-35 W. 63 feet to a stake, corner of said Noble lot; thence along her line, parallel with Buncombe Road N. 57-25 W. 200 feet to the beginning corner. Being part of Lots 3 and 4 according to a plat recorded in the R.M.C. Office in Plat Book "A", pages 610 and 511. This is a part of the land conveyed to A.M. Rush, O.D. Riddle and J.N. Bell by the Suburban Land Company, by deed recorded Vol. 16, page 284, the interest of said O.D.-Riddle being conveyed to A.M. Rush and J.N.
