

All that certain piece, parcel or lot of land lying and being in the State and County aforesaid and being in the Town of Greer on the West side of Depot or South Trade Street and having the following metes and bounds, to-wit: Beginning at a pin on West side of S. Trade Street and runs thence N. $97\frac{1}{2}$ feet to a pin; thence S. 200 feet to a pin; thence S. $97\frac{1}{2}$ feet to a pin; thence E. 200 feet to the beginning corner.

Beginning at a point on South Trade Street corner of R. C. Hendrick's lot and runs thence with South Trade Street S. 17 E. 87 feet to iron pin (corner of Camp Meeting lot) thence S 72.50 N. 208.6 feet to an iron pin in field; thence N. $14\frac{1}{2}$ W. 92.7 feet to corner of R. C. Hendrick's lot; thence eastward with his line about 206 feet to the beginning corner.

Also, all that certain piece, parcel or lot of land situate lying and being in the State and County aforesaid, Chick Springs Township, near the Town of Greer and having the following metes and bounds to-wit: Beginning, at a point on South Trade Street corner of Eschol Copeland's and runs thence with South Trade Street S. 17 E. 78 feet; thence nearly west about 206 feet; thence N. $14\frac{1}{2}$ W. 78 feet to Eschol Copeland's corner; thence Eastward with her line about 204 feet to the beginning corner.
