WHEREAS, *I Carrie S Nash*, the said *Carrie S Nash* in and by *my* certain note or obligation, bearing date the *6th* day of *August* 192*9*

incorporated under the laws of such State), in the sum of *Twelve Hundred (\$1200.00)* Dollars,

with interest thereon at the rate of *eight* per centum per annum, payable monthly, from the *6th* day of *August* A. D. 192*9*

according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that

the said *Carrie S Nash* shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the *20th* or before the end of the month of *August* 192*9*, and on the 20th or before the end of each month thereafter for twenty successive months the sum of *Sixty Seven (\$67.00)* Dollars,

being the regular monthly installment payable on the *Share* of Stock *Twelve* Dollars, being the monthly interest (on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of *Twelve* Dollars, being the monthly payment on said stock and *Five* Dollars, being the monthly interest on balance due);

for the next twenty months the sum of *Twelve* Dollars, being the regular monthly payment on said stock and *Five* Dollars, being the monthly interest on balance due);

*In Fairview Township, said Greenville County, State of South Carolina, Town of Fountain Inn, on the north side of Main Street, beginning on Main Street at the corner of another lot of said Mrs. Carrie S. Nash, and running along said Main Street N. 38 ft. 23 feet; thence N. 52 E. 150 feet to alley; thence along said alley S. 38 E. 23 feet; thence along line of said Mrs. Carrie S. Nash line S. 52 ft. to the beginning corner on Main Street and being a portion of lots conveyed to L. E. McKnight by deed of *Carrie S Nash* dated January 2, 1897 and recorded in the office of R. M.
