

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I Paul Harris of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting;

WHEREAS, I Paul Harris, the said Paul Harris, in and by my own certain note or obligation, bearing date the 27th day of July 1929, indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Eight Hundred (\$800.00) Dollars, with interest thereon at the rate of seven per centum per annum, payable monthly, from the 27th day of July A. D. 1929 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I the said Paul Harris shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of August 1929, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Twelve & 67/100 (\$12.67) Dollars, (\$8.00) Dollars, being the regular monthly installment payable on the eight Shares of Stock, and Four & 57/100 (\$4.67) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments and shares of the next twenty months pay the sum of Eleven & 73/100 (\$11.73) Dollars, being the regular monthly payment on said stock and Three & 73/100 (\$3.73) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Ten & 80/100 (\$10.80) Dollars, being the regular monthly payment on said stock and Two & 80/100 (\$2.80) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Nine & 87/100 (\$9.87) Dollars, being the regular monthly payment on said stock and One & 87/100 (\$1.87) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eight & 93/100 (\$8.93) Dollars, being the regular monthly payment on said stock and One & 93/100 (\$1.93) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said eight shares of stock and the certificate thereon, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made. One, the said and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against, me the said Paul Harris in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation and the condition hereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Paul Harris in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Paul Harris in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All those two certain lots or parcels of land lying and being in the City of Greenville, State and County of Greenville, and described as follows:  
Beginning on a stake on the west side of Center Street, corner of Lot no 59 and running thence with said street S. 15-21.60 feet; thence N. 77-30 21.88 feet to Mc Gee's line; thence N. 26-12 E. 61.2 feet with Mc Gee's line; thence S. 77-30 E. 76 feet to the beginning corner and known and designated as lots nos 60 and 61, according to a plat of Messrs. Seagan and Moeley made by R. E. Dalton, July, 1911 and filed in Plat Book A, at page 145, in the R. M. C. Office for Greenville County and being the same land conveyed to Paul Harris by J. B. Russell, February 16, 1923, by deed recorded in Volume 91, page 13, R. M. C. Office for Greenville County.
