

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Robert Scurry of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said Robert Scurry in and by my certain note or obligation, bearing date the 29th day of October 1929

indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Seven Hundred (\$700.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly, from the 29th day of October A. D. 1929, according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I

the said Robert Scurry shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of November 1929, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Seven + 08/100 (\$7.08) Dollars, (\$7.00 Dollars,

being the regular monthly installment payable on the seven Shares of Stock and 133 1/2 + 08/100 (\$4.08) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments and shall for the next twenty months pay the sum of Seven + 27/100 (\$7.27) Dollars, (\$7.00 Dollars,

being the regular monthly payment on said stock and 27/100 (\$0.27) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Seven + 45/100 (\$7.45) Dollars, (\$7.00 Dollars, being the regular monthly payment on said stock and 45/100 (\$0.45) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eight + 03/100 (\$8.03) Dollars, (\$7.00 Dollars, being the monthly payment on said shares of stock and 03/100 (\$0.03) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eight + 21/100 (\$8.21) Dollars, (\$7.00 Dollars, being the monthly payment on said shares of stock and 21/100 (\$0.21) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said seven shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me, the said

and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said Robert Scurry in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I the said Robert Scurry in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Robert Scurry

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All that certain lot situate in Ward Six (6) of the City of Greenville on the western side of Dixon Alley, said lot having a frontage of forty one (41) feet and a depth of one hundred fifty (150) feet, according to the Greenville City Block Book, said lot being designated as No. 20 of Section 4 as shown on Page 94 of said City Block Book and being the same lot conveyed to Robert Scurry by Louise B. Sawyer by deed of even date herewith to be recorded.
