

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN: William M. Thompson

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I, the said William M. Thompson in and by... certain note or obligation, bearing date the 3rd day of February 1930... indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of Fifteen hundred (\$1,500.00) Dollars, with interest thereon at the rate of Seven per centum per annum, payable monthly, from the 3rd day of February 1930 A. D. 192... according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I the said William M. Thompson shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of March 19230, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Twenty-three & 75/100 (\$23.75) Dollars, (\$15.00) Dollars, being the regular monthly installment payable on the fifteen Shares of Stock, and eight & 75/100 (\$8.75) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Twenty-two (\$22.00) Dollars, (\$15.00) Dollars, being the regular monthly payment on said stock and seven (\$7.00) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Twenty & 25/100 (\$25.25) Dollars, (\$15.00) Dollars, being the regular monthly payment on said stock and \$5.25 Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Eighteen & 50/100 (\$18.50) Dollars, (\$15.00) Dollars, being the monthly payment on said shares of stock and Three and 50/100 (\$3.50) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Sixteen & 75/100 (\$16.75) Dollars, (\$15.00) Dollars, being the monthly payment on said shares of stock and one and 75/100 (\$1.75) Dollars, being the monthly interest on balance due.) Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said fifteen shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made, the said William M. Thompson and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said William M. Thompson in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.

NOW, KNOW ALL MEN, That I, the said William M. Thompson in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said William M. Thompson in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

in the City of Greenville, having the following metes and bounds, to wit: Beginning on Croft Street at corner of lot No. 28, 217.5 feet west of Wilton Street, and running thence with line of lot No. 28, N. 1-41 E. 200 feet to an alley; thence with alley N. 83-13 W. 64.4 feet; thence S. 1-41 W. 200 feet to Croft Street; thence with Croft Street S. 83-13 E. 54.4 feet to the beginning corner, and being the eastern half of lot No. 26, Section B. of plat of Stone Land Company, said plat being recorded in Plat Book "A" page 337, and page 345, R. M. C. Office for said Greenville County, and being one of the same lots conveyed to Stella D. Stone by J. B. Stone February 24, 1910 recorded in Volume 9, page 72, said R. M. C. Office and being the same lot which was conveyed to said William M. Thompson by Stella D. Stone January 13, 1927.

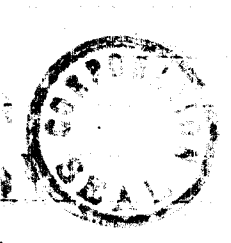
