TO ALL WHOM THESE PRESENTS MAY CONCERN:

I Sarah Levi -

of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:

WHEREAS, I Sarah Levi, the said, in and by my certain note or obligation, bearing date the 23rd day of March 1929, indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly incorporated under the laws of such State), in the sum of One Hundred Fifty (\$150.00) Dollars, with interest thereon at the rate of eight per centum per annum, payable monthly from the 23rd day of March A. D. 1929 according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that I the said Sarah Levi shall pay or cause to be paid to the said Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of April, 1929, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Three \$78.00 Dollars, (\$3.98) being the regular monthly installment payable on the said stock and One \$48.00 (\$1.48) Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of Three \$78.00 (\$3.07) Dollars, (\$2.50) being the regular monthly payment on said stock and One \$48.00 (\$1.17) Dollars, being the monthly interest on balance due); for the next twenty months the sum of Three \$78.00 (\$3.38) Dollars, being the regular monthly payment on said stock and One \$48.00 (\$3.08) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Three \$78.00 (\$2.50) Dollars, being the monthly installment on said shares of stock and One \$48.00 (\$2.79) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Three \$78.00 (\$2.50) Dollars, being the monthly installment on said shares of stock and One \$48.00 (\$2.29) Dollars, being the monthly interest on balance due.)

Each of the above payments to be made on the 20th or before the last day of each month, and shall thereafter surrender to the Company the said 2 1/2 shares of stock and the certificate thereof, the amount at such time paid shares by me to be credited as a payment upon the advance or loan made me the said Sarah Levi

and shall pay or cause to be paid all fines which may be lawfully imposed upon, or charged against me the said Sarah Levi.

in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said note or obligation, and the condition thereunder written, reference being thereunto had with more fully appear.

NOW, KNOW ALL MEN, That I Sarah Levi, the said, in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company, according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to me the said Sarah Levi,

in hand well and truly paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

Appx being known and designated as lot no. 2 in Block L, in Park place, as shown on plat of same recorded in P. M. C. Office for said Greenville County, said lot fronting Third Avenue fifty (50) feet and running back in parallel lines one hundred fifty (150) feet, and being the lot which was conveyed to said Sarah Levi by Mary L. Pack on February 19, 1920, by deed recorded in Deed Book 48, at Page 171 P. M. C. Office for said County.
