

THE STATE OF SOUTH CAROLINA,

TO ALL WHOM THESE PRESENTS MAY CONCERN:

I, Arnetta Moore
of Greenville, in the County of Greenville, and the State of South Carolina, send Greeting:
WHEREAS, I, the said Arnetta Moore
in and by my certain note or obligation, bearing date the 1st day of June 1929
indebted unto The Carolina Loan and Trust Company, of the City and County of Greenville, in said State (a body corporate, duly
incorporated under the laws of such State), in the sum of Three Hundred Fifty (\$350.00) Dollars,
with interest thereon at the rate of seven per centum per annum, payable monthly from the 1st day of June A. D. 1929
according to the provisions of the Charter, By-Laws, Rules and Regulations of the said Company, in manner and form following, that is to say, that
the said Arnetta Moore shall pay or cause to be paid to the said
Company, or its certain attorneys, successors or assigns, at Greenville City aforesaid, monthly, on the 20th or before the end of the month of June
1929, and on the 20th or before the end of each month thereafter for twenty successive months, the sum of Five & 54/100 (\$5.54)
Dollars, being the regular monthly installment payable on the three & one Shares of Stock and two Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of
Five & 13/100 (\$5.13) Dollars, being the regular monthly payment on said stock and one & 65/100 (\$1.63) Dollars, being the monthly interest on balance due);
for the next twenty months the sum of Four & 78/100 (\$4.78) Dollars, being the regular monthly payment on said stock and one & 22/100 (\$1.22)
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of Four & 32/100 (\$4.32)
Dollars, being the regular monthly payment on said stock and one & 22/100 (\$1.22) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of
Three & 9/100 (\$3.9) Dollars, being the regular monthly payment on said stock and one & 22/100 (\$1.22) Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of
Three & 9/100 (\$3.9) Dollars, being the regular monthly payment on said stock and one & 22/100 (\$1.22) Dollars, being the monthly interest on balance due).
Each of the above payments to be made on the 20th or before the last day of each month and shall thereafter surrender to the Company the said 3 1/2
shares of stock and the certificate thereof, the amount at such time paid shall be credited as a payment upon the advance or loan made by the said
Arnetta Moore and shall pay or cause to be paid all fines which may be duly imposed upon, or charged against me the said Arnetta Moore
Arnetta Moore in accordance with the Charter, By-Laws, Rules and Regulations, as in and by the said
note or obligation, and the condition thereunder written, reference being thereunto had will more fully appear.
NOW, KNOW ALL MEN, That I the said Arnetta Moore
in consideration of the said debt and sum of money as aforesaid, and for the better securing the payment thereof to the said The Carolina Loan and Trust Company,
according to the terms of said note or obligation, and also in consideration of the further sum of Five Dollars to
the said Arnetta Moore
in hand well and lawfully paid by the said The Carolina Loan and Trust Company, at and before the sealing and delivery of these Presents, (the receipt whereof is hereby
acknowledged), have granted, bargained, sold and released, and by these Presents, do grant, bargain, sell and release unto the said The Carolina Loan and Trust
Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

All those certain lots situated in
Greenville Township, designated as lots nos 1 and
2, in Block B of Summit View, according to
a plat recorded in Plat Book A, at page 75,
R. M. C. Office for Greenville County, and
having the following metes and bounds.
Beginning at the northwest corner of
Church and Goldfield Streets, and thence
running in a westerly direction with Church
Street 167.6 feet to an alley; thence along
the line of said alley N. 40 E. 135 feet to
the corner of lot no 3; thence with the
line of lot no 3 S. 50 E. 150 feet to Goldfield
Street; thence with the line of Goldfield
Street S. 40 W. 64 feet to the beginning
corner, being the same lot conveyed to
Arnetta Moore by Jena Mc Gee October 19,
1928, by deed recorded in Volume 156, at
