WHEREAS, *S. M. Compton*, the said *S. M. Compton*

Dollars, (*\$6.00*) Dollars, being the regular monthly installment payable on the *five* Shares of Stock and *Three + 50¢ (\$3.50)*
Dollars, being the monthly interest on the advance or loan) until there have been paid twenty monthly payments, and shall for the next twenty months pay the sum of
Eight + 80¢ (\$8.80) Dollars, (*\$6.00*) Dollars, being the regular monthly payment on said stock and *Two + 80¢ (\$2.80)* Dollars, being the monthly interest on balance due);
for the next twenty months the sum of *Eight + 100¢ (\$8.10)* Dollars, (*\$6.00*) Dollars, being the regular monthly payment on said stock and *Two + 100¢ (\$2.10)*
Dollars, being the monthly interest on balance due); for the next twenty months pay the sum of *Seven + 100¢ (\$7.40)*
Dollars, (*\$6.00*) Dollars, being the regular monthly payment on said stock and *One + 40¢ (\$1.40)* Dollars, being the monthly installment on said shares of stock and
the sum of *Six + 70¢ (\$6.70)* Dollars, (*\$6.00*) Dollars, being the monthly interest on balance due); for the next twenty months pay the

acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto *S. M. Compton* the said The Carolina Loan and Trust
Company, all that tract or parcel of land, situated in the County of Greenville, State of South Carolina, and described as follows:

In the subdivision known as *Greenwood Heights*, as shown on a plat recorded in *Book A*, at page 133, R. M. C. Office for *Greenville* County, and being designated as lot no. *96* of said subdivision and having the following metes and bounds:-

Beginning at an iron Pin on main Street and thence running along the same N. 62 1/2° E. 50 feet to an iron Pin thence still along main Street S. 61 1/2° E. 183 feet to an iron Pin on the right-of-way of Southern Railway Company; thence S. 62 1/2° W. 153 feet to an iron Pin at the corner of *J. N. Page* lot; thence N. 22-45° W. 150 feet along the page line to the beginning corner, and being the same lot conveyed to *S. M. Compton* by *Julia P.
