bargain, sell and release unto the said *Harriet M. Stone*

County and State aforesaid, fronting on Shebster  
Street and having the following mftes and bounds  
Beginning at a stake on the north side of Shebster  
Street as now widened, (being 21 1/2 feet from the  
corner of Shebster and Fall Streets) thence with Wood's  
line northward, about 70 feet to a stake on Mrs Mat-  
tie L. Silreath's line, eastward 9 1/2 feet to a stake,  
corner of lot now or formerly owned by Mrs A. C.  
Davis; thence with line of Mrs Davis, lot, south-  
ward, about 71 feet to a stake on Shebster Street,  
thence westward, with Shebster Street 9 3/2 feet
