WHEREAS, Lee H. Eagle, the said Lee H. Eagle SEND GREETINGS:

in and by my certain promissory note in writing, of even date with these presents am well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of Five Hundred and no/100 Dollars,

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold, aliened, conveyed, released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

*Greenville Township known as lot no. 60 on plat of lands of Prides + Patton Land Company made by R. E. Dalton, Engineer, and recorded in Office of R. M. C. for said County in plat Book E. Page 249, and having the following courses and distances according to said plat: Beginning at an iron pin on the north-east side of Heatherly Drive 150 feet west of Valley Street, corner of lot no. 59, and running thence with line of said lot N. 36-15 E. 150.1 feet to an iron pin, corner of lot no. 69; thence with line of said lot N. 59-23 W. 50.24 feet to iron pin, corner of lot no. 61; thence with line of said lot S. 36-15 W. 145.2 feet to iron pin on Heatherly Drive; thence with Heatherly Drive S. 53-45 E. 50 feet to the beginning.*
