SEND GREETINGS:

WHEREAS, *we*, the said *W. H. Look and Octavia Look*

in and by *our* certain promissory note in writing, of even date with these presents *are* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Fifteen hundred, & no/100* Dollars,

to be paid on or before the date when the *31st* Series of the Instalment Stock of the said AMERICAN BUILDING AND LOAN ASSOCIATION shall reach maturity, with interest thereon from date at the rate of eight per cent. per annum, payable weekly on or before Saturday night of each and every week until paid in full; and if *we* fail to pay said interest or comply in all respects with the By-Laws of said Association, for the space of thirty days, then said debt shall become immediately due and payable, together with all interest, fines and expenses, and all amounts advanced by the said Association on the within described property, by way of taxes or insurance, *the same* to be added to the amount due on said note and to be collectible as part thereof, together with an attorney's fee of ten per cent. if the same be placed in the hand of an attorney for collection or if said debt, or any part thereof, be collected by an attorney, or legal proceedings of any kind (all of which is secured under this mortgage), as provided in and by the said note, reference being thereunto, had, will more fully appear.

NOW, KNOW ALL MEN, That *we* the said *W. H. Look and Octavia Look*

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said AMERICAN BUILDING AND LOAN ASSOCIATION, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to *us*, the said *W. H. Look and Octavia Look*,

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina,

All our right, title and interest in and to the same being an undivided one-half interest in and to see that Piece, Parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in the 5th ward of the City of Greenville, containing 275 square feet more or less, on the north side of Pendleton Street, and having the following meter and bounds, to-wit:

Beginning at a stake 37 on Pendleton Street corner of Carpenter and Leach lots and running thence with line of Leach Lot n. 22 w. 133.5 feet to a stake 3v; thence n. 68 w. 47 feet to a stake 3x; thence s. 22 e. 133.5 feet to a stake 3z on North side of Pendleton Street; thence along north side of Pendleton Street s. 68 e. 47 feet to the beginning corner, and being the same lot of land conveyed to us by Charles H. Carpenter by deed dated April 18, 1927, recorded in the R. M. C. office for Greenville County in Deed Book 104, Page 528.
