SEND GREETINGS:

WHEREAS, *we*, the said *Francesco Fazio and Camilla Fazio*.

*near corporate limits of city of Greenville, South Carolina, known as portion of lot no. 9 in plat of lands of the Melville Land Co. recorded in Plat Book 6, Page 97, fronting fifty feet on Holly Pine and Traction Street, and running back on mason street fifty feet to lot of Henry M. Keel and conveyed to Francesco Fazio and Camilla Fazio by deed recorded in Vol. 99, Page 401.*
