WHEREAS, *I*, the said *Paul Whisnaut*

in hand well and truly paid by the said AMERICAN BUILDING AND LOAN ASSOCIATION at and before the signing of these Presents, the receipt thereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said AMERICAN BUILDING AND LOAN ASSOCIATION all that piece, parcel or lot of land lying in Greenville County, South Carolina, *Greenville Township,*

near Judson Mills, known as the Southern Portion of Lot No. 1 on Plat of lands of J. O. Heatherly, recorded in office of R. M. C. for said County in Plat Book E, Page 238, and having the following courses and distances: Beginning at stake, corner of Judson Mills, on the north side of Heatherly Drive, and running thence with Heatherly Drive S. 29-26 E. 70.2 feet to Stake, corner of lot no. 2; thence with line of lot no. 2 in a northeasterly direction 150 feet to stake; thence in a northwesterly direction about 62 feet to stake in line of Judson Mills; thence S. 49-59 W. 155 feet to the beginning.
