WHEREAS, *I*, the said *B. F. Jones*

in and by *my* certain promissory note in writing, of even date with these presents *am* well and truly indebted to AMERICAN BUILDING AND LOAN ASSOCIATION, a corporation, incorporated under the laws of the State of South Carolina, in the full and just sum of *Twelve Hundred and <sup>no</sup>/<sub>100</sub>* Dollars,
