in Butley Township, known as Lot # 1, in Block D, in Carolina Court, a subdivision near Greenville on the Laurens Road, a plat of said subdivision being of record in the A. M. C. Said plot has a frontage on the Laurens Road of 67 feet 8 inches, a depth along Monticello Avenue of 198.7 feet; is 64.1 feet wide at the rear and has a depth along its southern boundary of 198.9 feet.
